The Opposition On Catch Me If You Can A Good Lawyer I was recently perusing the Internet when I came across a website that offered a review of a book. In this review, the author stated that he found his experience with the book to be disappointing. After reading the book, this author noted that he "felt it lacked a sense of what would happen if he really went to court." The same author received a different opinion from the person who evaluated the book for another website. When this author asked her for a review, she wrote that she found the book to be "strong" and "very useful." I was thinking about this experience as I just concluded a class on contracts for lawyers. From reading the client's response to my contract, I believe the second author is correct in her opinion. The legal complexity of contracts tends to complicate matters for the inexperienced lawyer. We all know that contracts are a big part of lawyer's income, but don't make the legal process easy for yourself. In spite of what you might learn in legal training, you may need to study contracts to understand it. And, you may realize that you have absolutely no idea what you are doing when it comes to contracts. I am convinced that most people don't know what they are doing with contracts when they read them. Contracts are complicated because they deal with lots of things: who is bound to whom, when the time for performance will occur, payment procedures and terms, who is the one who cannot perform, how to cancel the contract, how to enforce the contract, the client's right to receive the full amount if the client desires to terminate the contract, and on and on. As a result, we hear much talk about what makes a good contract. I'll add that there is no right or wrong way to write a contract. The contract is a document that is worded to satisfy the needs of the parties involved. The better the contract, the fewer problems that will occur. But, that does not mean that the contract will always be an effective tool in solving problems. What I am suggesting here is that we talk more about contracts in the context of what happens if there is a breach of contract. Let's put down some of the basics: Damages. In most legal systems, a party can sue to enforce a contract, or to seek damages. Damages are the amount of money that will compensate the party for a breach of contract. Damages in a breach of contract case are often small as the other party has already paid up. In my experience, some contracts lack provisions for how to deal with damages. In my contract class, we spent quite a bit of time looking at the damages in the contract at issue. Enforcing a Contract. Contracts are often written to protect the party who does not want the contract to be enforced. For example, in the situation in which a new customer refuses to pay and then the lawyer writes a contract that does not permit the lawyer to take the

matter to court, then the lawyer would not pursue the matter. Restitution. The other party often has an obligation to pay restitution to another party when there has been a breach of contract. This usually occurs when a party failed to perform on a contract. When a contract is cancelled, the party that cancelled generally does not have to pay restitution for all of the services the other party rendered.
